

SUPPLEMENT TO THE RESIDENTIAL PARKING PERMIT (RPP) PETITION FORM

AREA “P” NEAR UCSF BENIHOFF CHILDREN’S HOSPITAL OAKLAND (CHILDREN’S HOSPITAL)

As part of the condition of approval for construction addition to Children’s Hospital, the developer set aside money for a Residential Permit Parking program (Area “P”) within the area and zones (attached) as defined by the Oakland City Council as part of approval of the project.

The process to be included in this area requires a submitted petition signed by residents from more than 50% of addresses per block where applicable.

By signing and initializing the attached petition, I acknowledge the following regarding RPP area “P” implementation:

1. I have read and completely understand the terms and conditions of this petition.
2. I agree to have permanent Residential Permit Parking on my block.
3. I understand that, pending the outcome of the petition process, RPP area “P” signage may be placed on my side of the street.
4. I understand that for eligible residents permit fees will be paid by Children’s Hospital for a period of ten years from when RPP became enforceable. If construction lasts longer than ten years, Children’s Hospital will be obligated to pay for the RPP permits for the additional length of construction.
5. I understand that the Hospital will only fund one (1) permit per residence on parcels that have a driveway and two (2) permits per residence with parcels that do not have a driveway. However, a residence can apply for additional permits, up to permitted maximum of three (3) per residence. These additional permits shall be funded by the resident.
6. I understand that after the ten year period noted above, the City Planning Commission shall make a recommendation to City Council regarding 1) whether the Hospital can achieve the reduction goals established by the TDM program while eliminating Hospital-related parking in the RPP area in the absence of the RPP program and 2) the continuation or discontinuance of Hospital funding of the RPP program. If the RPP is not extended, all residents in area “P” will be responsible to pay permit fees in accordance with Oakland Municipal Code for Residential Permit Parking and the Master Fee Schedule. The current residential permit fees is \$82.

We, the undersigned, are residents and/or business owners of the proposed Preferential Residential Permit Parking Area described in this petition and supplemental form. We understand that, if this area is designated as a Preferential Residential Permit Parking area, certain restriction will be placed upon on-street parking within the designated area; that subject to the regulations and restrictions established by the City Council, their visitors will be eligible to obtain permits exempting them from such parking restrictions; that the annual fee for a Residential Parking Permit is \$82 per vehicle; that a Residential Parking Permit may be issued to a resident of the same address, but not more than **three** Residential Parking Permits shall be issued to any one address, except in areas where it appears that the number of permits issued would exceed the number of legal on-street parking spaces where the initial sale would be limited to two or possibly one permit per resident; that no more than one Residential Parking Permit shall be issued to each motor vehicle owned or leased for which a application is made; residents may purchase temporary permits for visitors; that fees for one-day and two-week Visitor Parking Permits are \$9.00 and \$25.00 per vehicle, respectively; a resident may purchase up to five of both on any calendar day. We, the undersigned, hereby request that the City Council consider this petition for establishment of the above-described area as a Preferential Residential Permit Parking Area.

Upon return of the completed petition, The City Traffic Engineer will evaluate the petition, hold neighborhood hearing(s), and make a recommendation to the City Council in accordance with Ordinance No. 10689 C. M. S. of the Oakland Traffic Code.
